The Village of Montpelier will receive sealed bids in their office, at 211 North Jonesville Street, Montpelier, Ohio until 2:00 P. M. Local Time on March 9, 2022 for Brown Rd\Cr K & Airport Rd\Cr 13 Road Improvements DEY08 for Montpelier, Ohio. At the close of time for accepting bids, all bids will be transported to the Montpelier Police Department, 221 Empire St. Street, Montpelier, Ohio 43543, where they will be publicly opened.

Complete sets of bidding documents, including plans and specifications for the project will be available for examination, Monday through Friday from 8:30 a. m. to 4:30 p. m. at the above-named office. Copies may be obtained by request from the Village of Montpelier, 211 North Jonesville Street, Montpelier, Ohio 43543, 419-485-5543. A nonrefundable fee of \$40.00 will be charged per set. An additional of \$15.00 will be charged for Bidding Documents that are to be shipped. All fees must be paid prior to shipping. Checks should be made out to the Village of Montpelier. Bidding Documents, Plans, and Specifications may be viewed and downloaded at no cost from the Williams County Engineer's Web Site <http://wmscoengineer.com/bidprojects.asp> at no charge.

Bids must be submitted on the forms found in the Bidding Document; must contain the names of every person or company interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The Owner intends and requires that this project be substantially complete no later than August 5, 2022, with final Completion by August 12, 2022.

Each bidder shall be required to file with his proposal a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code. The guaranty shall be a bond for one hundred percent (100%) of the bid amount. A certified check or cashier's check for ten percent (10%) of the bid can be submitted in lieu of a bond. The successful Bidder will be required to furnish a satisfactory Performance Bond for one hundred percent (100%) of the bid amount.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project.

Special Attention Must Be Given to all the requirements contained in the bid packet, particularly to ORC 4115 prevailing wages, various insurance requirements, and the requirement for a performance bond for 100% of the contract price.

Any bid may be withdrawn prior to the schedule closing time for the receipt of bids, but no bidder shall withdraw his bid within 30 days after the actual opening thereof. The Village of Montpelier reserves the right to reject any or all bids, waive irregularities in any bid, and to accept any bid which is deemed most favorable to the Village.
