PART 1 – GENERAL

1.01 Work Included, But Not Limited To

- A. **Furnish various quantities of Spray Chemicals in manufacture's containers** listed on the bid form to various locations in Williams County as designated by the Williams County Engineer or the Williams County Drainage Engineer.
- B. **Furnish various quantities of bulk Spray Chemicals** listed on the bid form to various locations in Williams County as designated by the Williams County Engineer or the Williams County Drainage Engineer. It is the intent of the Engineer to purchase chemicals in the largest possible containers to meet the anticipated need, unless otherwise noted in the proposal.
- C. **Provide bulk containers for temporary storage** of Spray Chemicals for Spray Chemicals in paragraph B. listed above, as required by the Williams County Engineer or the Williams County Drainage Engineer. It is understood that empty containers may remain property of the supplier and may be picked up at his convenience after use.
- D. **Provide 2 Each – One Gallon Graduated Measuring Container (Clear)** and Resistant to the effects of Chemicals contained herein
- E. **Engineer** will purchase products from the various suppliers based on price and other good and valuable considerations. **Listed products may be purchased from various vendors.**
- F. **MSDS Sheets and Products Labels: MSDS and Labels Sheets Must Be Made Available Upon Notification of a Purchase or of a Possible Purchase. These Items Do Not Need to Be Submitted With The Proposal.**
- G. Adhesive labels will be required for ALL chemicals delivered in bulk for use on the County's bulk storage tanks.

1.02 Quality Assurance

- A. The **Bidder** shall have a minimum of five (5) years of experience in furnishing the materials listed for this project.
- B. Areas available for storage of material and equipment shall be as designated by the Engineer.
- C. The materials delivered to Williams County shall not be delivered in containers that have been used for other grades or mixes of chemicals that would affect the performance of the product delivered, or the equipment used to apply the Spray Chemicals by the Engineer. If it becomes apparent that the tankers used for delivery of Spray Chemical products are contaminated with dissimilar materials and/or products, the Engineer will notify the supplier of said condition. The bidder will replace the contaminated material with new material at no cost to the Engineer. The Engineer shall document the cost incurred by Williams County as a result of the contaminated Spray Chemicals, and this amount will be deducted from the payment due to the bidder.
- D. The Williams County Engineer will consider or equal products for all of those listed in the Proposal.
- E. The Engineer will make the final determination as to "or equal, or equivalent" status of any products submitted in the proposal.
