## REQUEST FOR QUALIFICATIONS

# PROJECT #7-2018 – WILLIAMS COUNTY ENGINEERING SERVICES FOR KUNKLE WASTEWATER TREATMENT PLANT

The Williams County Board of Commissioners is requesting Statements of Qualifications from Engineers for services as described below.

Project Description: Williams County is requesting proposals for the design of a wastewater treatment plant to serve the unincorporated area of Kunkle. The treatment plant will be a lagoon system that will provide service to approximately 90 households. The collection system will be designed by the Williams County staff.

Williams County would like to enter into a Professional Services contract as soon as possible and have specific deadlines from OEPA as listed in the requirements.

It is our intention to provide for open competition for the afore-mentioned professional services, where firms' qualifications are evaluated, and once a firm is selected, fair and reasonable compensation is negotiated. We are inviting interested individuals and firms to submit evidence of their professional qualifications, and related information.

Williams County hopes to enter into a single Professional Services Contract containing the following general areas:

- 1. Final Planning: Assist Owner in final selection of land for lagoon site.
- 2. Design: Design treatment plant and provide complete construction drawings to Owner to be submitted to OEPA for a PTI.
- 3. Inspection: Construction inspection for treatment plant.

The Statement of Qualification should adhere to the requirements listed under the following "Requirements for Statements of Qualifications".

It is our intent to give reasonable consideration to at least three (3) firms based on their qualifications so as to have one or more alternative firms to enter into negotiations, if negotiations with preferred firm are not satisfactory.

- 2. Statements of Qualifications must be received in our office on or before 4:30 p.m. on November 20, 2018. Statements of Qualification received after this time **will not** be considered.
- B. Statement of Qualifications Format:
  - 20 pages maximum including a cover letter.

## Firm Background

Provide the firm's name, contact information, and brief background. List the location of the office where the majority of the work will be performed. Company brochure and promotional materials, if available, may be included at the end of your submission.

2 pages maximum

#### **Project Understanding**

Briefly describe the firm's overall understanding of the project.

2 pages maximum

#### Personnel

Identify the Project Manager and other key staff members by name and title. Include project engineers for important disciplines and staff members responsible for key elements of the required services. Describe the experience of persons to be assigned to the Project on projects similar in scope and size. Provide professional resumes of staff members who would be assigned to the project.

6 pages maximum

# Qualifications, Availability and Experience

Describe the firm's resources including staff available and equipment. Describe the firm's availability and current workload. Detail efforts made on previous projects to control cost. Provide detailed description of similar projects with location and final cost.

8 pages maximum

#### References

Include references of the Professional Design Firm that the County may choose to contact for an assessment of the firm's credentials to perform required services.

1 page maximum
