The Engineer reserves the right to reject loads that are non-conforming, including but not limited to: mud balls, oversized aggregate, foreign matter, excessive dust and fine material, or other materials that impede chip seal operations.
- C. Items 6, 7, 16, 17, 26, 27 shall conform to ODOT CMS 703.05 as well as the Gradation Specification listed below. The Engineer reserves the right to reject loads that are non-conforming, including but not limited to: mud balls, oversized aggregate, foreign matter, excessive dust and fine material, or other materials that impede chip seal operations.

## PART 2 PRODUCTS

### 2.01 Delivery, Handling, and Storage
